The Fund aims to provide long-term growth by investing in one or more passively managed emerging market equity funds. These funds invest predominantly in equities in emerging economies, including those of companies listed on developed market exchanges whose activities predominantly take place in emerging market countries.

The Fund will only invest in passive index tracking funds. Where the Fund invests in more than one fund, the allocation between these funds will be re-balanced periodically.

These funds may use derivatives for the purpose of efficient portfolio management, reduction of risk or to meet their respective investment objectives (including taking short positions) where permitted and appropriate.

The value of investments within the Fund can fall as well as rise and is not guaranteed – you may get back less than you put in.
