The Fund aims to provide long-term growth by investing in one or more passively managed Sterling denominated corporate bond funds. The Fund may also hold funds that invest a proportion of assets in other bonds (such as overseas bonds, high yield bonds and gilts) and in money market instruments such as Floating Rate Notes (FRNs) and Certificates of Deposits (CDs).

The Fund will only invest in passive index tracking funds. Where the Fund invests in more than one fund, the allocation between these funds will be re-balanced periodically.

These funds may use derivatives for the purpose of efficient portfolio management, reduction of risk or to meet their respective investment objectives (including taking short positions) where permitted and appropriate.

The value of investments within the Fund can fall as well as rise and is not guaranteed – you may get back less than you put in.
The Sterling value of overseas assets held in the Fund may rise and fall as a result of exchange rate fluctuations.

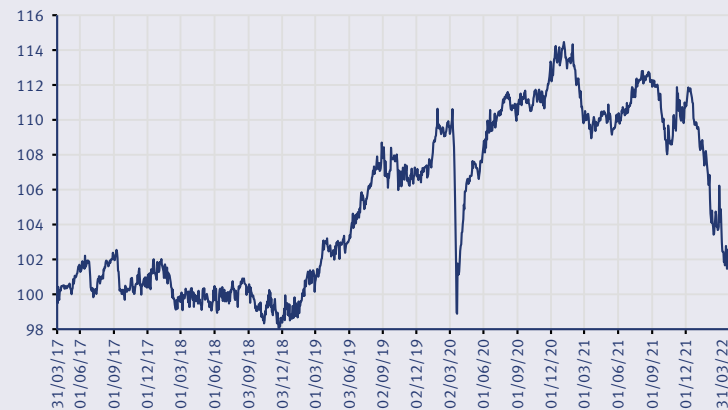
