<p>The SL Stewart Investors Global Emerging Markets Leaders Pension Fund invests primarily in the Stewart Investors Global Emerging Markets Leaders Fund. The aim of the Stewart Investors Global Emerging Markets Leaders Fund is summarised below.</p> <p>The Fund aims to achieve capital growth over the long term (at least five years). The Fund invests in shares of large and mid-sized companies in emerging markets or where the majority of their activities take place in emerging markets. This includes companies that are listed on exchanges in developed markets. These companies generally have a total stock market value of at least US\$1 billion. Emerging market countries are those which are not classified as developed markets by MSCI or FTSE, or which are categorised by the World Bank as middle or low-income, or which are not members of the Organisation for Economic Co-operation and Development. The Fund may invest up to 10% in other funds. 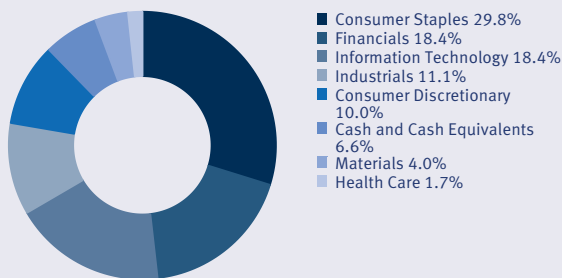

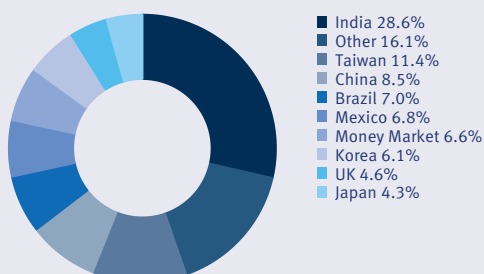
