The SL Baillie Gifford Managed Pension Fund invests primarily in the Baillie Giff Managed Pn. The aim of the Baillie Giff Managed Pn is summarised below.

To invest in equities, fixed interest securities and cash either directly or through other Baillie Gifford Pooled Fund. The Managed Pension Fund aims to outperform its benchmark by 1–1.5% p.a. (before fees) over rolling 3 year periods.

The value of any investment can fall as well as rise and is not guaranteed – you may get back less than you pay in.

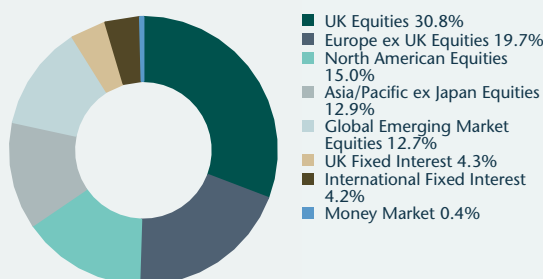

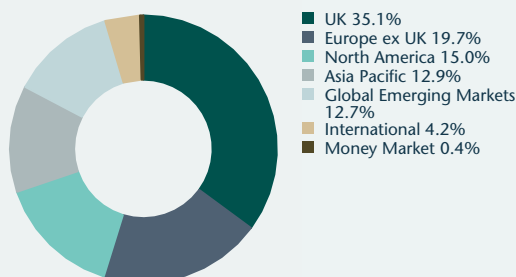
