<p>The SL Ninety One Global Multi-Asset Sustainable Growth (CR) Pension Fund invests primarily in the Ninety One Global Multi-Asset Sustainable Growth Fund. The aim of the Ninety One Global Multi-Asset Sustainable Growth Fund is summarised below.</p> <p>The Fund aims to provide real returns (in excess of UK inflation, currently measured by the increase in the UK Consumer Price Index (CPI)) through capital growth (to grow the value of your investment) and income over at least 5 years. 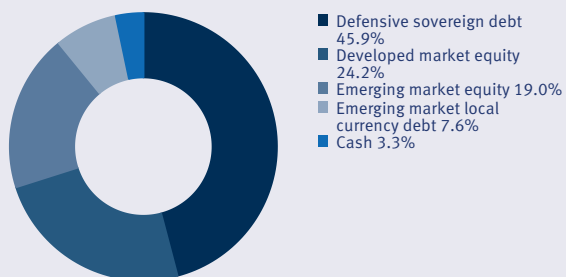
