<p>The SL State Street ACS Multi-Factor Global ESG Index Equity Pension Fund invests primarily in the State Street ACS Multi-Factor Global ESG Index Equity Fund. 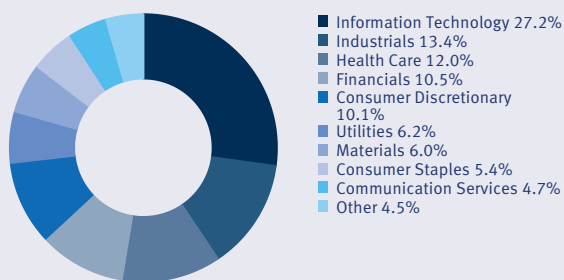

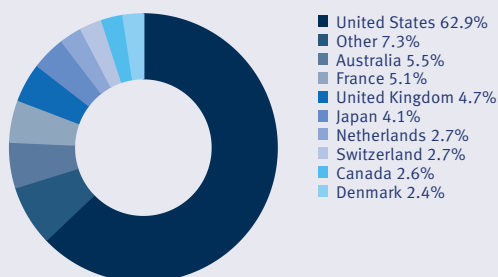
