The fund has approximately 50% invested in the shares of UK companies. 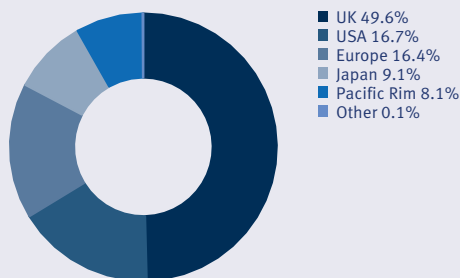

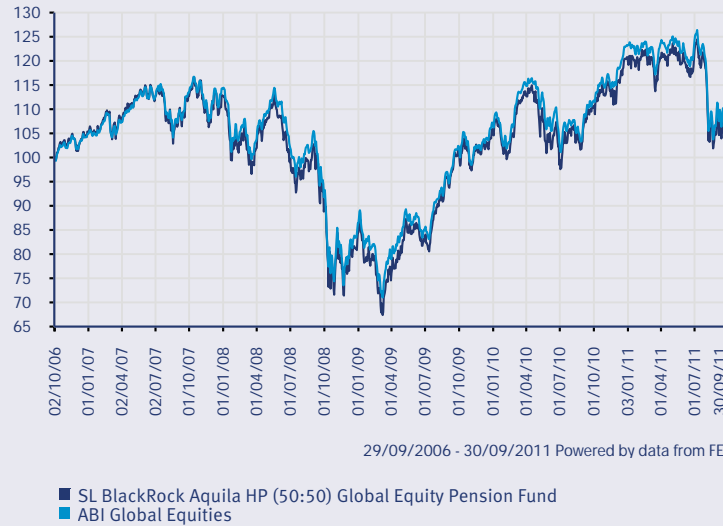
