<p>The SL BlackRock ACS World ex UK Equity Tracker Pension Fund invests primarily in the BlackRock ACS World ex UK Equity Tracker Fund. The aim of the BlackRock ACS World ex UK Equity Tracker Fund is summarised below.</p> <p>The Fund is a sub-fund of BlackRock Authorised Contractual Scheme I taking the form of a co ownership scheme. As a consequence of this, the Fund may be treated as tax transparent for the purpose of income and/or capital gains by relevant taxing jurisdictions. Each investor should take appropriate professional advice as to the tax treatment of their investment in the Fund. Investors in the Fund must be Eligible Investors as defined in the Fund's prospectus and must have completed all relevant documentation prior to the purchase of units in the Fund. 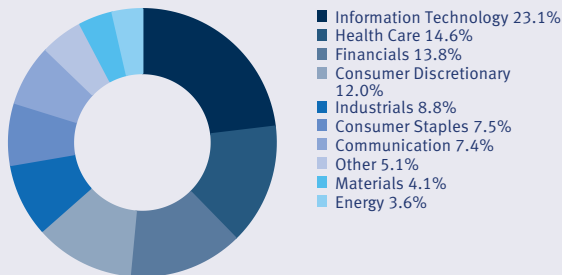

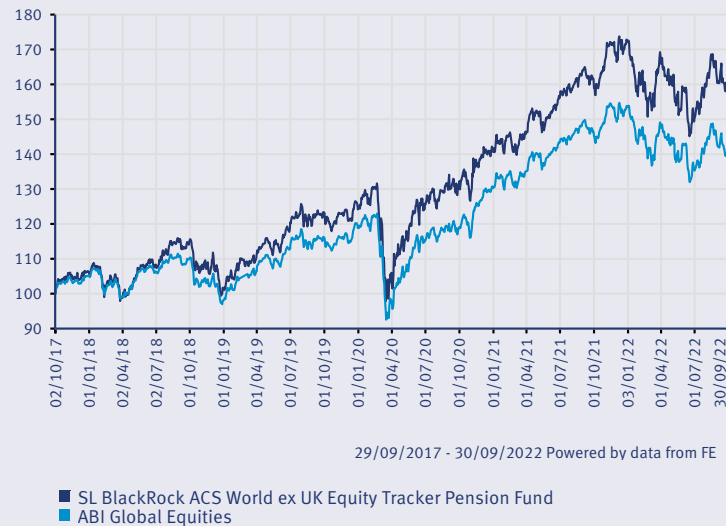
