Fund commentary (as at 30/06/2024)


A large part of the portfolio is invested in US equities and government bonds, with an emphasis on the former. While it was a subdued period for Treasury bonds, it was another good quarter for US equities, which were boosted by the strength of technology shares amid the growth of AI. However, in response to the elevated valuations of technology stocks, we preferred to broaden exposure to US quality-growth companies by realising some gains on the regional US equity allocation and adding to the Global Select Fund, as well as the Global Focus Fund. Elsewhere, there were smaller reductions to equities in Europe, the UK, Asia and Japan, although we added to Treasury bonds. Additionally, within the US equity position, we adjusted exposure to different strategies.
