Fund objective

The Sterling Adventurous fund aims to provide the potential for long-term growth and the risk profile of this investment choice is the highest of the five managed funds. The exposure to equities is generally higher than that of the other investment choices in the Managed range, with a lower exposure to money market instruments. The investment choice may also utilise fixed interest instruments in certain circumstances.

Fund information

This investment choice is a portfolio internally managed by Zurich on a discretionary basis. The investment policy is overseen by Columbia Threadneedle Investments according to investment mandates set and controlled by Zurich.

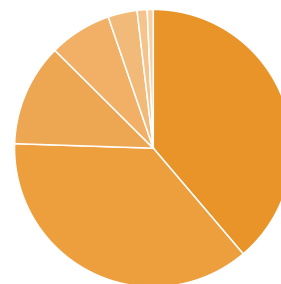
Fund commentary (as at 30/06/2024)

The portfolio invests in a range of global stock markets, with a focus on the UK, which rose in Q2. The further easing of inflation buoyed hopes that the Bank of England could begin cutting rates in the autumn. Meanwhile, a general election was called for 4 July. By far the largest portfolio adjustments were to increase global equities while scaling back the regional US equity allocation. Given the elevated valuations of US technology stocks, we preferred to broaden exposure to US quality-growth companies by adding to the Global Select Fund, as well as the Global Focus Fund. We also reduced equities in Japan, Europe and Asia and modestly trimmed the UK. Additionally, within the UK, US and Europe, we adjusted exposure to different strategies.
