
Fund information

This investment choice is a portfolio internally managed by Zurich on a discretionary basis. The investment policy is overseen by Columbia Threadneedle Investments according to investment mandates set and controlled by Zurich.

Fund commentary (as at 30/06/2024)

The majority of the fund is invested in equities with an emphasis on the UK, where the market rose in Q2. A further easing of inflation buoyed hopes that the Bank of England could begin cutting interest rates in the autumn. Meanwhile, a general election was called for 4 July. The largest portfolio changes were to increase global equities while scaling back the regional US equity allocation. Given the elevated valuations of US technology stocks, we preferred to broaden exposure to US quality-growth companies by adding to the Global Select Fund, along with the Global Focus Fund. We also reduced equities in the UK, Europe, Asia and Japan, and trimmed gilts. Additionally, within the UK and US equity allocations, we adjusted exposure to different strategies.
