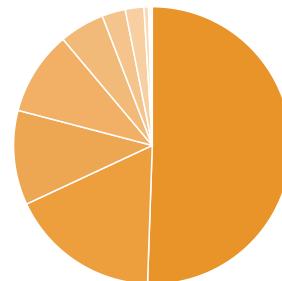
Fund commentary (as at 30/06/2024)

A large portion of the fund is invested in US equities, with a smaller allocation to US government bonds. While it was a subdued quarter for US Treasury bonds, US equities performed well, boosted by the strength of technology stocks amid the growth of AI. By far the biggest portfolio changes were to increase global equities while scaling back the regional US equity allocation. Given the elevated valuations of US technology stocks, we preferred to broaden exposure to US quality-growth companies by adding to the Global Select Fund, as well as the Global Focus Fund. We also reduced equities in the UK, Asia, Japan and Europe, but added to Treasury bonds. Additionally, within the US equity allocation, we adjusted exposure to different strategies.
