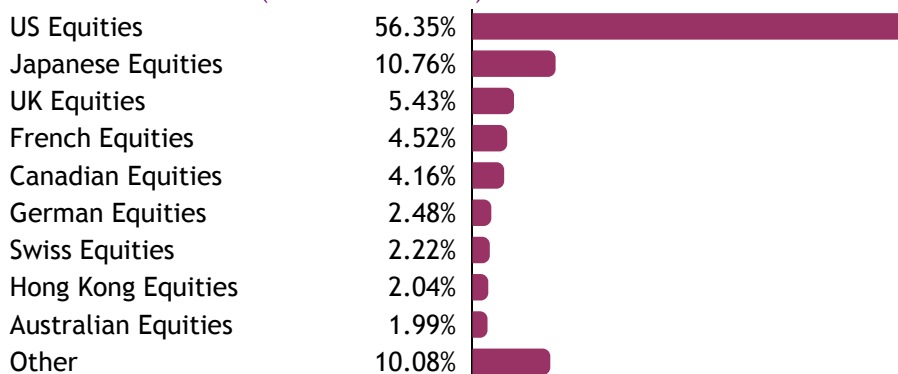

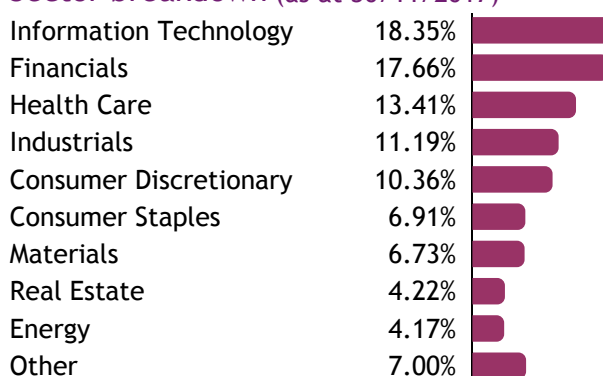

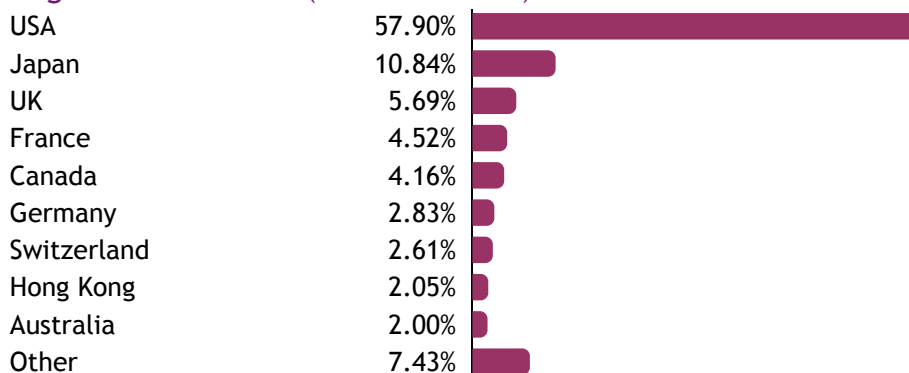
Asset breakdown (as at 30/11/2017)
