The Fund may also provide exposure to equities (which may include UK, overseas and emerging markets), commodities and other alternative assets such as derivatives.

In addition the Fund has the power to invest in other asset classes permitted by FSA rules.

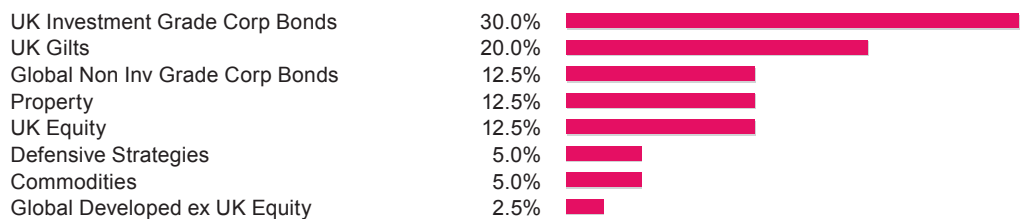
Quarterly Fund Manager Review
