The Fund may also provide exposure to property (which can be both in the UK and overseas) and bonds (this may include UK Government bonds, index-linked securities, other UK fixed interest securities, overseas bonds and high yield bonds). In addition the Fund may also provide exposure to commodities and other alternative assets such as derivatives. The Fund has the power to invest in other asset classes permitted by FSA rules.

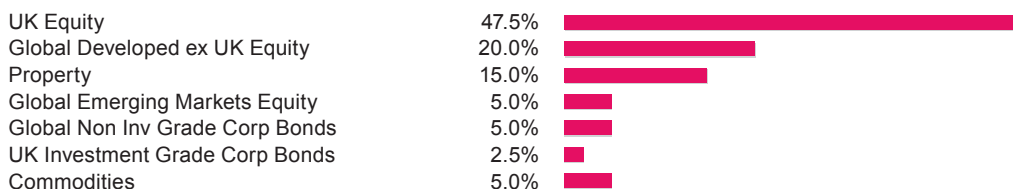
Quarterly Fund Manager Review
