Fund objective

This fund aims to provide a balance of income and capital growth, however there may be some risk to capital. 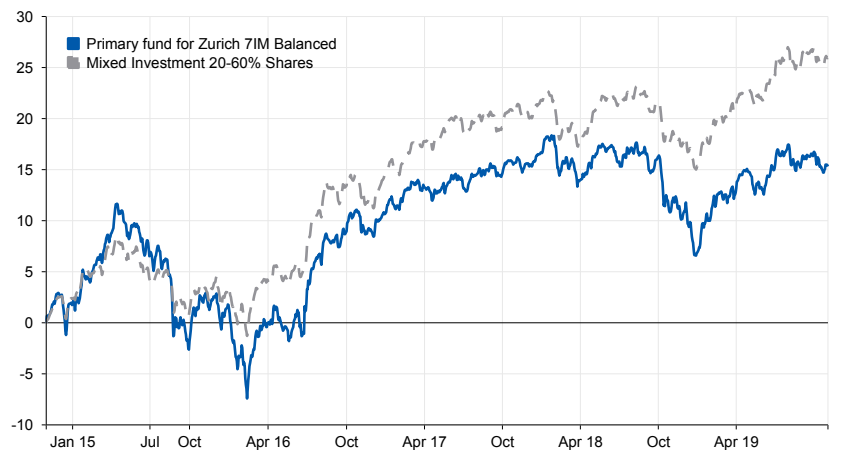
