### Fund objective

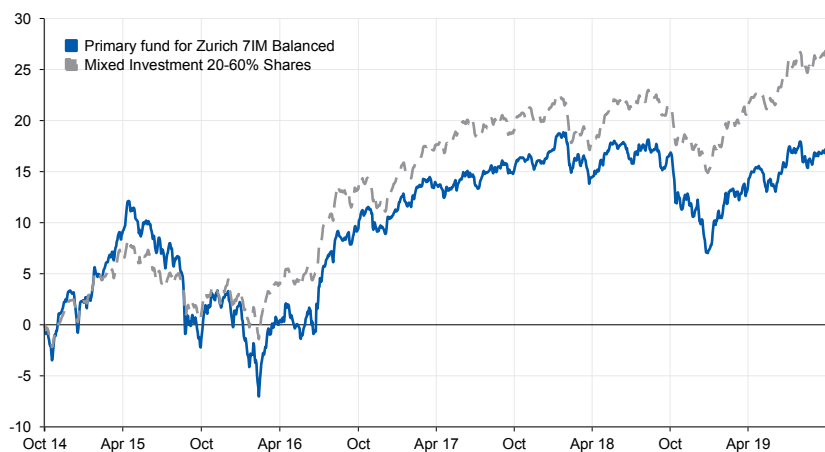
